During the 2023-2024 school year over 75 Teaching Artists served over 850 students with our social-emotional learning-based curriculum. In fiscal year 2024, we increased our investment in local talent by 20%.

Each Children's Orchestra student, 4 in 5 of whom qualify for free or reduced lunch, received over 16 hours of music teaching, lessons, and support per week for 576 hours of instruction annually. Students were also provided with snacks and academic help. 100% of our seniors graduated high school and pursued higher education.
